Marina Market now offers inside and outside locations. Inside spaces are \$25 per day when each month is paid in full in advance. Otherwise weekly fee is \$35. Vendors with inside booths will keep the same location from week to week. Displays and merchandise can be left up from week to week. Inside spaces include one 6 foot table and 2 chairs. Spaces are approximately 6'x8'. Extra tables are \$5 per week. Outside spaces are \$10 each week. Nothing is provided outside. Vendors are responsible for their own tents, chairs and tables.

Market Hours: 10 to 3 every Saturday SET UP TIME: 9 to 10 each Saturday morning. Vendors need to be ready for business promptly at 10. Vendors are responsible for their own extension cords, peg board hooks, light bulbs, tape, table drapes and display. Vendors may park in front of the market to unload, but need to park in back of the market building before opening. Vendors are also responsible for their own trash disposal and for keeping their booth space clean and neat.
